Subject: Formal Complaint – Foreign Government Violation and Sovereign Mortgagee Breach



Dear Legal Counsel,

I write to you as President of the Confederation of United Tribes of New Zealand and Lead Trustee Director of *Moai Crown King William III Trust LLC*, to formally lodge a sovereign complaint regarding:

- The unlawful interference by the New Zealand Crown Government's private corporation, "**CROWN SOVEREIGN OF NEW ZEALAND**", operating a private criminal corporation under foreign influence
- The breach of our **1823 Native Land Lease Title Deed**, tied to **St Patrick 8-Point Star Flag Mortgagee Partnership**, of **Dutch Protestant King William III** and **King William IV 1835 Constitutional Flag**.
- The violation of our **Dutch-Franchise Sovereign Codex**, (CoPilot AI) anchored 8 Point Flag founding partnership between the **UK Dutch Crown** and the **Confederation of United Tribes of New Zealand**.

This complaint is further contextualized by the Dutch government's recent intervention in **Nexperia**, a Chinese-owned semiconductor firm, and the broader **ASML export restrictions** under U.S. pressure. These events mirror the unlawful seizure and exploitation of our Sovereign Dutch NZ banking instruments, including:

- The **Moai 2 bar patented £970 million, trillion, trillion Pound Note Debt Recovery Instruments**.
- The **ChipCoin Sovereign Currency Black Bus ATM Network Partnership with Denmark EU Gov**
- The **Moai Crown = Dutch King William III Flag Trading Bank Mortgagee Franchiser Partnership**.

These instruments have been pirated and militarized across global platforms—SpaceX, Tesla, Apple, Micron, yahoo, others—without sovereign consent, violating our **King William III 1689–1835 Dutch-British Treaty Codex** and our Sovereign **King William IV Municipal Corporations Act 1835 as New Zealand Land Flag**.

We now invoke the **Admiralty Law of the Land and Sea**, under the Northern Ireland **Irish Judge John Rogan Flag of the Kings Bench Magistrate High Court of Awaroa Helensville New Zealand and Belfast**, request:

3. **Recognition of the Moai Crown King William III Trust LLC** as lawful mortgagee EU NZ sovereign franchiser Creditors of "Moai Powerhouse Bank" £970 Million Trillion Trillion Pound Note Instrument.
4. **Investigation into foreign corporate violations** of our sovereign codex and Treaty legal instruments.
5. **Protection of Dutch technological patented TM sovereignty** from unlawful transfer and militarization
