A — COMPANY OWNERSHIP

Na Atua E Wa Aotea Limited registered 17 August 2009, NZ Companies Office.

999,999,999,999 shares issued under my authority as President (2009–2026).

I hold the Edinburgh Magistrate Court Title Deed linked to the Manukau Land Company 201-year lease with King George IV.

I am the successor to Mohi Te Maati Manukau, Native Magistrate and Freemason of 60 years.

B — PURPOSE OF ENGAGING EDDIE MITCHELL

In 2023 I instructed Eddie Mitchell to take three memory sticks containing sealed Native Magistrate Court documents to Westminster.

Purpose: verify and activate the Manukau Land Company lease, and raise capital for the Kaipara Harbour Moai Tidal Energy Project.

C — AUTHORITY CONTEXT

My authority derives from:





Te Tii Marae Whakamunenga Lower House, Waitangi.

Manukau–Rogan whakapapa (Irish Freemason lineage).

King William III / IV Native Land Contracts.

This establishes jurisdiction for my claims and instructions.

D — RED FLAG 1: FALSE BANK STORY

Eddie claimed he needed NZD \$33,000 to register “NA ATUA E WA AOTEA LIMITED No.1” with IBC Bank Singapore.

Investigation confirmed:

IBC = International Baptist Church, not a bank.

Actual company registration cost in Singapore = NZD \$1,500–\$3,200.

This is the first confirmed deception.

E — RED FLAG 2: CASH DEMANDS

Eddie demanded \$5,000 cash from each of the five Māori chiefs present.

No receipts issued.

Phillip Te Awhitu (who provided the \$5,000 cash)

F — RED FLAG 3: SILENCE + AVOIDANCE

After receiving funds, Eddie stopped responding to all communications.

No registration completed.

No progress on the Westminster instruction.

G — RED FLAG 4: COMPANY RECONSTRUCTION ATTEMPT

Eddie attempted to reconstruct my company into the Mitchell Family Trust.

This is an unauthorised attempt to seize ownership of:

My company

My land lease rights

My Crown contract authority

H — RED FLAG 5: MEMORY STICK THEFT

Eddie took the three memory sticks containing:

King William III / IV Native Magistrate documents

Manukau Land Company lease evidence

Rogan–Manukau whakapapa authority





These documents were used without my consent.

I — RED FLAG 6: UNLAWFUL CASHING OF CONTRACT

Eddie and his associates appear to have cashed the contract value in either:

Bank of Scotland (Paterson Pound Note – forbidden under Westminster law), or

Bank of England

Estimated value: USD \$17 trillion.

This triggers international money-laundering liability.

J — RED FLAG 7: GOVERNMENTAL NON-ACTION

I contacted:

NZ Police

NZ Crown

Singapore AML

Australia AML

Scotland AML

Westminster AML

Irish authorities

US Federal agencies

No action taken.

This creates Crown liability for non-intervention.

K — RED FLAG 8: SPENDING OF STOLEN FUNDS

Evidence suggests Eddie used the stolen funds to acquire:

Shopping malls

Investment companies

Retirement funds

Mansions

Supermarkets

Vehicles

Dubai investments

Queenstown investments

Chinese business partnerships

L — RED FLAG 9: PUBLIC AFFIDAVITS UNREBUTTED

Over 1,600 video affidavits published across multiple platforms.

All remain unrebutted, establishing default judgment under contract law.





M — RED FLAG 10: COVER-UP

Multiple agencies failed to act despite evidence.

This constitutes a systemic cover-up of white-collar fraud.

N — RED FLAG 11: TAX-FREE CHINESE WATER COMPANY

Eddie invested in a tax-free water bottling company.

CEO contact details provided to Richard for verification.

Source of funds unexplained.

O — RED FLAG 12: IMPOSSIBLE PROFIT DECLARATION

Eddie generated USD \$17 trillion in under 12 months.

No tax returns or work records exist to justify this.

Na Atua E Wa Aotea Limited (2009)

This is consistent with:

Contract law

Default judgment

Fraud recovery

Precedent similar to US asset forfeiture cases

R — CURRENT STATUS

Four major contracts (Moai Hydrogen Economy + Japanese Aquafarms) are delayed due to Eddie's actions.

Losses continue to accumulate.

S — FINAL POSITION

I am the Judgement Creditor.

Eddie Mitchell is the Judgement Debtor.
