(a) **BASIC OFFENSE.**—Whoever, whether in time of peace or in time of war and with the specific intent to destroy, in whole or in substantial part, a national, ethnic, racial, or religious group as such—

- (1) kills members of that group;
- (2) causes serious bodily injury to members of that group;
- (3) causes the permanent impairment of the mental faculties of members of the group through drugs, torture, or similar techniques;
- (4) subjects the group to conditions of life that are intended to cause the physical destruction of the group in whole or in part;
- (5) imposes measures intended to prevent births within the group; or
- (6) transfers by force children of the group to another group;

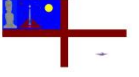

(b) **PUNISHMENT FOR BASIC OFFENSE.**—The punishment for an offense under subsection (a) is—

- (1) in the case of an offense under subsection (a)(1), where death results, by death or imprisonment for life and a fine of not more than \$1,000,000, or both; and
- (2) a fine of not more than \$1,000,000 or imprisonment for not more than twenty years, or both, in any other case.

(c) **INCITEMENT OFFENSE.**—Whoever directly and publicly incites another to violate subsection (a) shall be fined not more than \$500,000 or imprisoned not more than five years, or both.

## Comparing XRP and XLM: Insights from My Research



### Core Purpose & Target Audience

- XRP is mainly used by banks and financial institutions for interbank settlements.
- XLM is decentralized and focuses on individuals and small businesses, especially in developing countries.
- XRP is designed for large-scale financial infrastructure, while XLM prioritizes accessibility and inclusion.

### Consensus & Technology

- XRP uses Ripple Protocol Consensus Algorithm (RPCA) with a Unique Node List for validation.
- XLM uses Stellar Consensus Protocol (SCP) with federated voting among trusted nodes.
- Both enable fast, secure, low-cost transactions but differ in decentralization and validation methods

### Token Design & Distribution

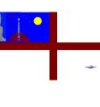
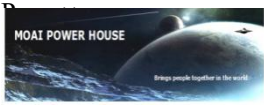
- XRP's total supply of 100B was created at launch and is deflationary.
- XLM started with 100B tokens but was reduced to 50B through community decisions.
- These distribution models affect supply-demand dynamics and price behavior.

### Current Status & Future Outlook

- XRP faces ongoing regulatory challenges in the U.S., impacting institutional adoption and price.
- XLM operates with regulatory approval and partnerships (e.g., VISA, Circle), supporting smoother growth.
- XRP's future depends on legal resolutions, while XLM's adoption grows steadily with ecosystem expansion.

# SEC-CFTC Joint Staff Statement (Project Crypto-Crypto Sprint)

## Staff of SEC and CFTC

## Introduction

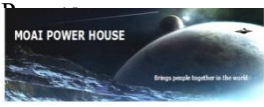
The SEC's Division of Trading and Markets and the CFTC's Division of Market Oversight and Division of Clearing and Risk (collectively, the "Divisions")<sup>[1]</sup> are announcing a cross-agency initiative in furtherance of the SEC's Project Crypto and the CFTC's Crypto Sprint to coordinate efforts regarding the process for enabling the trading of certain spot crypto asset products.









The President's Working Group on Digital Asset Markets report on "Strengthening American Leadership in Digital Financial Technology" (the "PWG Report") recommends that the SEC and CFTC coordinate to make America the best place in the world to innovate with blockchain technology and participate in crypto asset markets.<sup>[2]</sup> Specifically, the PWG Report recommends that the agencies should use their existing authorities to promote "regulatory clarity that best keeps blockchain-based innovation within the United States." As part of this effort, the Divisions are coordinating to issue guidance "regarding the listing of leveraged, margined, or financed spot retail commodity transactions on digital assets" to implement the PWG Report recommendations.

This joint statement provides the Divisions' view that current law does not prohibit SEC- or CFTC-registered exchanges from facilitating trading of these spot crypto asset products. As contemplated by the PWG Report, the Divisions' coordination will promote trading venue choice and optionality for market participants within the United States. In line with these goals, the Divisions stand ready to support consideration by their respective agencies of exchange trading in certain spot crypto asset products.

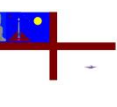
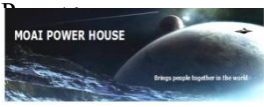

# XRP ETF 2025: THE NEXT INSTITUTIONAL CATALYST



## INTRODUCTION

- The U.S. SEC's mid-2025 decision on a spot XRP ETF is one of the most anticipated events in crypto. Prediction markets place approval odds at 87%, with potential inflows of \$5–\$8 billion—a move that could reshape institutional access to XRP.

## REGULATORY MOMENTUM

- SEC Settlement (Aug 2025): Ripple paid \$125M, ending years of litigation.
- Outcome: XRP confirmed as a non-security in open-market transactions.
- Impact: Opened the door for 300+ bank partnerships and ETF filings by 16 fund managers, including Bitwise, Grayscale, and WisdomTree.

## MARKET IMPACT &

- ETF Inflows: Estimated \$5–\$8B in the first month of trading.
- Price Targets: Analysts see \$5–\$10 by 2025, with technicals pointing as high as \$20 long-term.
- Comparisons: Bitcoin ETFs drew \$50B AUM; Ethereum ETFs \$27.6B by mid-2025. XRP is next in line.

## XRP'S REAL-WORLD UTILITY

- Cross-Border Payments: On-Demand Liquidity (ODL) cuts costs by up to 70% and reduces settlement times to seconds.
- Banking Adoption: 300+ banks and institutions exploring XRP for remittances and treasury operations.
- DeFi Expansion: Ripple's EVM sidechain integrates Ethereum-compatible DeFi apps while keeping XRP's low fees and 3–5 second settlement times.

## RISKS & ROAD AHEAD

- Risks: Regulatory delays, geopolitical bans (e.g., China), macroeconomic volatility.
- Opportunities: ETF infrastructure growth, increasing institutional liquidity, and XRP's proven efficiency in payments.
- Big Picture: Approval would cement XRP as a mainstream digital asset, rivaling Bitcoin and Ethereum ETFs in institutional portfolios.

## REGULATORY MOMENTUM

#XFINANCEBULL

- Ripple Settlement (Aug 2025): \$125M fine ended the SEC case.
- Result: XRP officially recognized as a non-security in open-market transactions.
- Why it matters: Cleared the path for 300+ bank partnerships and gave confidence to ETF applicants.
- ETF Filings: 16 fund managers—including Bitwise, Grayscale, and WisdomTree—submitted updated proposals for an XRP ETF.





## ISO 20022

A global financial messaging standard that enhances transaction speed, security, and interoperability. It enables seamless communication between banks, payment networks, and financial institutions. Cryptos like XRP, XLM, XDC, ALGO, and IOTA align with ISO 20022, positioning them for mainstream adoption in cross-border payments. 🚀



### Stablecoins & IMF Approval

The IMF (International Monetary Fund) recognizes certain digital assets like Stellar (XLM) and Ripple (XRP) for their potential in cross-border payments. These assets align with global financial standards, ensuring stability, security, and efficiency in digital transactions. 🌍💰

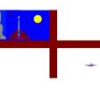
Good morning, Chair Scott, Ranking Member Warren, and members of the committee. Thank you for the opportunity to appear before you today. My name is Brad Garlinghouse, and I am the CEO of Ripple. Ripple has nearly 900 employees across our 15 offices worldwide.

Ripple was founded more than a decade ago with a mission: to enable the *Internet of Value* — a world where money moves like information does today. We build software products that power cross-border payments, stablecoins, and digital custody. Ripple helps financial institutions reduce friction, unlock efficiencies, and serve their customers better. These are not abstract concepts—we work everyday with banks that rely on our technology to deliver real results in the global economy.

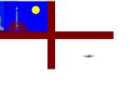
Ripple leverages the XRP Ledger—a decentralized, battle-tested open source blockchain - and its native digital asset, XRP, to facilitate payments. XRP is built to enable fast, low-cost, and highly scalable transactions.

With regard to the topic of this hearing, we believe smart legislation should be based on several core principles: consumers need protection from fraud and scams, markets need proper oversight,





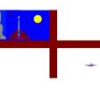
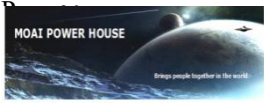
